2. If any case arises, as per the requirement, one external expert from amongst NGOs committed to the cause of women or a person familiar with the issues related to sexual harassment shall be co-opted on need basis.

3. Terms of reference to the Committee are:

- a) The Committee will receive all the complaints in connection with sexual harassment, examine whether or not, prima facie, such conduct constitutes an offence under the law or a breach of the service rules.
- b) To conduct inquiry for cases of sexual harassment of women at work place and submit its findings to Disciplinary Authority / Management.
- c) To conduct special drive to review the pending cases and appropriate action to be taken before 9th December, 2022.
- d) The Committee shall make an annual report of the complaints indicating the action taken by them and submit to Head-HR for further action.

4. Women employees are requested to forward their complaints on sexual harassment, if any, in a CONFIDENTIAL cover to the Presiding Officer of the Complaints Committee.

5. This issues with the approval of Competent Authority and will come into force with immediate effect.
