**OFFICE ORDER**

The Director, ICAR-Central Institute of Fisheries Education, Mumbai has allotted **Flat No. 103** in the **Type V Quarters** at CIFE New Campus to **Shri K. L. Meena, Chief Administrative Officer (SG), ICAR – CIFE, Mumbai** on the following terms & conditions mentioned here under:

1. He will vacate the Type V Quarter if any Senior Administrative Head senior to him joins the Institute.
2. That the license fee shall be recoverable from his salary under F.R. 45-A with effect from the actual date of occupation of the flat.
3. That he should furnish a declaration in the prescribed form that he owns/ does not own a house in the District of Mumbai either in his name or any of his dependant family members.
4. The recovery of license fee shall be made as per revised rates issued by the Govt. of India, Ministry of Urban Development & Poverty Alleviation, Directorate of Estates, New Delhi vide Office Memorandum No. 18011/2/2015-Pol.III dated 19th July, 2017 and No. 18011/2/2015-Pol.III dated 29th June, 2020 from the date of occupation of the said quarter. He is not eligible for the payment of HRA.
5. The recovery of license fee for the officers owning houses at/ near stations of their posting will be charged at the enhanced rates as per the ICAR orders issued from time to time.
6. He should also abide by all relevant rules and orders as modified from time to time by the CIFE/ ICAR.
7. That the allotment of the Quarter No. 303 will stand cancelled, if its acceptance is not received within eight days from the receipt of this Office Order of authorization will debar the allottee to apply for a period of three months from the date of non-acceptance subject to payment of one month's normal licence fee.
