At ICAR Hgrs.

The powers to sign Vakalatnama and pleadings on behalf of the Director General, ICAR and Secretary, ICAR have been delegated to the Legal Adviser or to the officer assigned with the work/charge of Legal Adviser and in his absence to the Joint Secretary (Admn.) and in his absence to the Joint Secretary (Per.).

Further, the above delegation will be subject to the following conditions:

 Copy of the office order of delegation will be attached with each Vakalatnama signed by the above officers.

(ii) Neither any officer of the Institute nor Zonal Legal officer nor the advocate receiving the Vakalatnama shall be authorized to give commitment on behalf of ICAR, or make any pleading regarding ICAR policies, without the specific approval of ICAR Hgrs.
