- 1. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Parameters for technical evaluation of bids:

- 1. Scanned copy of undertaking of "Bid Security Declaration" accepting that if the bidder withdraw or modify their bids during period of validity etc., they will be suspended for 2 years. (Mandatory for all bidders including MSMEs/NSIC/Startups)
- 2. Scanned copy of Undertaking that the bidder has never been black listed/banned/debarred etc. by any govt. Organization/Departm ent during last three years.
- 3. Scanned copy of PAN Number and GSTIN registration Certificate.
- 4. - 6. The Service Provider shall have a legal status. It can be a registere d Partnership Firm/ Company under Companies Act having legal entit y with all statutory licenses/ registration for carrying out such activities like registration with labour department, PF Act, 1952, ES I Act, 1948, Income Tax Act etc. Documentary evidence in support of the claim to be submitted by the bidder while bidding.
- 9. Bidder must provide Escalation matrix/Dedicated/toll free/helpli ne Number for service support.
- 11. Scanned copy of undertaking that the bidder has never been declared Bankrupt/insolvent by any bank/financial agency of central or state government.

Disclaimer/अस्वीकरण

- 11. Creating bid for items from irrelevant categories.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
