OFFICE ORDER

On the recommendations of the Compassionate Appointment Committee and after having been medically examined by the prescribed Medical Authority, the Director, ICAR-National Dairy Research Institute, Karnal has been pleased to appoint Smt. Poonam w/o Late Sh. Vikas Kumar on Provisional Basis to the Group "C" Skilled Support Staff post on Compassionate grounds in the Level-1 of 7th CPC w.e.f. 17.02.2022 (FN) i.e. date of her joining as per terms & conditions mentioned in the Offer of appointment issued vide O.M. No. F.2-43/2015-16/NDR-IV(S)/1406-07 dated 28.10.2021 as accepted by her.
