

CIRCULAR

It is to inform that the Rate Contract 2020-21 for purchase of Chemicals, Glassware, Plasticwares, Liquid Handling System, and Sequencing etc. has been extended up to 01.01.2022 to 31.03.2022 on the initial terms and conditions as enunciated in extension letter No. 1-1/RC/Chem/2020-21/S(P)-1 dated 08.02.2022.

However, to ensure that GFR provisions are complied with and to ensure smooth conduct of research activities, Competent Authority has decided the following:-

- (i) All items to be purchased through GeM mandatorily if available.
- (ii) In case of non-availability on GeM purchase may be taken up as per GFR154/155 depending on the cost involved.
- (iii) In case where purchase as per GFR154/155 may not be feasible due to non availability of manufacturer / authorized dealer in Karnal and nearby markets, purchase through rate contract may be resorted as special case by the Director. All indents for purchase of Chemicals, Glasswares, Plascticware etc. should be generic. However, in case where Catalogued Chemicals i.e. of a specific make are required to be purchased, Indenter may submit the Indent having due justification for the same. The above proposals should be duly vetted by the DPAC.
- (iv) Indenters shall proceed with the purchase through GFR 154 by following instruction as enunciated in Institute's circular No.TEC/PAC meeting/89250 dated 24.11.2021 and dated 29.11.2021.
- (v) Indenting Officer shall have to obtain a certificate from the vendor that he has quoted the rates reasonability and has not supplied Chemicals etc. anywhere at rates below the quoted rates.

Rest of procedure mentioned in office order No.1-1/RC/Chem/2020-21/S(P)-1/252-263 dated 23.10.2021 shall remain same.
