- a) The firm shall charge GST @5% on the invoice raised which shall payable by the institute
- b) In case of CNG vehicles, it should have valid registration of CNG vehicle and the CNG should be company fitted only and must have adequate space for keeping the luggage in
- c) Firm has to provide as many vehicles as per demand, even on short notice. In case of failure of the contractor, necessary action, as deemed fit, will be taken.
- d) The firm shall fulfil GST provisions as per existing guidelines of the government and must have valid GST Registration.
- e) The contracting firm cannot change the rate of vehicles during the contract period for any reason.
- f) The contract can be terminated at any time, without assigning any reason, which is at the sole discretion of the Director, NDRI; Karnal.

- g) The driver shall be experienced with sound health and must possess valid driving license issued by the Regional Transport Authority (RTA) or Regional Transport Office (RTO) which should be of at least 3 years old and without any adverse marking/remarks thereon.
- h) Drivers have to follow all guidelines/advisories issued by the government of COVID-19 and Rules & Regulations of Traffic/Driving.
- i) The vehicles are to be supplied and work has to be executed strictly as per the satisfaction of user.
- j) The vehicle should be in good running condition and should not be more than 05 year old.
- k) The vehicles should be commercial vehicle, insured and registered with Company as well as RTO.
- 1) Toll tax & parking charges will be paid by ICAR-NDRI, Karnal on production along with bills.
- m) The vehicles provided must be clean, with proper seats and seat belts. The tyres of such vehicles must be in good condition.
- n) No on-way stop is allowed except as desired by the user.
- o) The institute is not liable to attend any Challan of the firm's vehicle and its related expenses, institute will not pay any damage occurred to the vehicle for whatever reason.
