4. Warranty

1. The bidder shall be fully responsible for installation, testing, commissioning and providing after sales services comprehensive support. An undertaking

from the manufacturer is required in this regard stating that the OEM would facilitate the bidder on a regular basis with technology/product updates and extended support for warranty as well.

- 21. The bidder must be a reputed manufacturer (OEM) or its authorized System Integrator of the type of products offered. In case of system integrator, a letter of authorization from OEM, specific to the tender should be enclosed. The bids received without the authorization letter from the OEM are liable to be rejected.

- 54. If any extra device is required for storage of logs data of users that will be provided by the bidder otherwise these modules should be available in firewall.
